6.b Russia Anti-Gay Legislation

Whereas on June 29, 2013, Russian Federation President Vladimir Putin signed into law the bill banning the promotion of information about "non-tradition" sexuality; and

Whereas prior to the signing of this law, the Parliamentary Assembly of the Council of Europe had called on the Russian authorities to drop the law noting that it was "at variance with freedom of expression and the prohibition of discrimination on account of sexual orientation and gender identity"; and

Whereas Human Rights Watch considers the law to be discriminatory against member sof the LGBTQ Community; and

Whereas the Russian Federation will be hosting the 2014 Winter Olympics in Sochi, Russia; and

Whereas RUSA LGBTQ, a Russian-speaking LGBT organization based in New York, has called for a boycott of the 2014 Sochi Olympics; therefore

Be it resolved that the Student Association of George Brown College write a letter condemning the recent discriminatory laws enacted by the Russian Federation; and

Be it further resolved that the SA lobby the Canadian government to also condemn the recent discriminatory laws enacted by the Russian Federation.
