III. Approval of minutes from last meeting

No minutes available from last meeting. Committee referred to CRO and DRO 2017 Spring General Elections reports.

IV. Open issues

a) Nomination Dates

Discussion:

Tiffany – the Bylaws state that the nomination period must be a minimum of 5 business days (Article 13.7 on page 24 of the Bylaws). The AGM has been scheduled already for September 27 to correct the issues with our Bylaws that currently prevent many students from running for certain positions, particularly if a by-elections must be held for the executive positions.

Faris – we need to ensure that we also look at the holidays calendar provided by the College to ensure we don't unintentionally exclude students from the elections process.

Jessica – Be cautious about the Friday times, as we close early on Fridays. If we keep nominations open until 4:30 pm on the Friday, then we will need to discuss this with SAMS staff.

b) Campaign Dates

Discussion:

Tiffany – The Bylaws state that the campaign period needs to be a minimum of 10 business days, with a 5 day overlap for the voting period (Article 13.8.b. on page 24 of the Bylaws).

Jessica - October 9 is Thanksgiving. We can have the All Candidates Meeting take place after Thanksgiving, which prevents any issues for those who are leaving early Friday to go away for the long weekend.

Faris – Sukkoth is a Jewish holiday that will be occurring Oct 5, 6, 10 and 11, and it's an important holiday in the Jewish community. This will impact a couple of days within both the nominations period and the campaign period, but it should be okay if it only impacts the last two days of nominations and only two out of the ten minimum days of campaigning.

Mick – The Dialog won't be able to publish candidate bios in the paper because it will be too close to the deadline for submissions, so we can create an ad in The Dialog to refer students to the SA website to see bios.
